You can only use a personal internet-capable device (no company supplied devices).

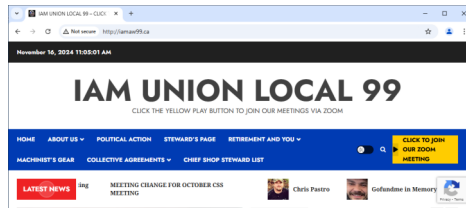
Every virtual participant must use their first and last name as their screen name.
